Attached please find true and correct final information concerning the AAUP Advocacy Local – AFT 6741 Officer and Delegate Election.

MK Elections mailed the ballots on March 29, 2024. During the open period of the election, the ballots were returned to a post office box owned by MK Elections in Pittsburgh, PA and remained in the custody of MK Elections until the ballot pickup. The ballots were counted at the offices of MK Elections in Pittsburgh on April 29, 2024 starting at 8:30AM. A Zoom link was provided to candidates who were interested in following the ballot count, and at least one union member was present at all times.

The initial group of 1008 ballots was counted by 11:30AM. Because of a delay cause by the USPS not being initially able to find 137 ballots that were charged to us, but not in the box, we paused and resumed the ballot count at 1:30 PM after receiving those ballots from the post office.

During the open period of the election MK Elections tracked the return of undeliverable ballots and mailed replacement ballots to voters upon their request and/or the request of the organization. Complete information about voters, undeliverables, replacement ballots sent, and other detailed information is attached to this letter and available in the electronic files that accompany this report.

We certify that the attached results and ballot information attached are true and correct, and that they properly reflect the paper record of the election which has been sealed and left in your custody.
